Community Pool Party Rules and Regulations

1. A 50% **non-refundable** deposit is due at the time of reservation.
2. All fees must be paid to the Conejo Recreation & Park District 10 days prior to the party date.
3. No refunds for parties will be given if the party is cancelled less than 10 days prior to party date.
4. The party host organizing the party may arrive at the location 30 minutes prior to the start of the party. **Cleanup must be finished by the end of the scheduled party time or a \$1/minute fee will be applied for each minute the party runs over originally scheduled time.**
5. In case of inclement weather, you may transfer your party to another available day. No refunds will be granted unless the facility is forced to close.
6. Alcohol may not be served, nor may any person appear in the facility in an intoxicated condition.
7. No smoking in the facility.
8. All regular pool rules are enforced
9. No water wings allowed. Only Coast-Guard approved life jackets with a strap between the legs are permitted.
10. All other floats and toys are allowed with the manager's discretion.
11. Active, in-water supervision may be required for non-swimmers.
12. At no time will music be allowed to constitute a nuisance, cause offense to the public, or be allowed to violate any noise ordinance; The renter remains fully responsible for such compliance. CRPD management reserves the right to determine if music content is appropriate for the facility.
13. Outside party materials (including decorations and food) may be brought in by the party host; it is the responsibility of the party host to set up/remove and serve such items.
14. The parent organizing the party may not leave the party site until all minors have been picked up. CRPD is not responsible for any children after the conclusion of the party.
