SUBJECT: California's Severe Drought and Conejo Recreation and Park District's Response in Terms of Water Conservation Recommendations

On May 7, 2015, the Board directed staff to provide monthly reports of the District's water use, water savings projects, and activities to date.

Water Use

Attached is the monthly water use report, including:

- Water use from June 1, 2015 to July 1, 2017 as compared to same months in 2013
- District's Water Usage per Acre (All Funds)
- Overall Water Costs (All Funds)
- Rainfall

FY 2016/2017 Water Savings Projects and Activities

- Capital Projects
 - Drought Response Irrigation Improvements and Turf Conversions – Districtwide
 - ◆ Twenty-six parks approved by Metropolitan Water District (MWD) for turf rebate funds in the amount of \$720k. All funds received.
 - ◆ Received additional rebate funds (\$233k) from Cal Water for turf conversions over and above MWD program
 - Investigate/Develop Conversion to Reclaimed Water at Triunfo Community Park
 - ◆ Turf rebate application submitted and approved for \$50k. Waiting on rebate.
 - ◆ Work completed April 2017
 - Six Pickleball Courts and Turf Conversion at Rancho Conejo Playfield
 - ◆ Turf rebate application approved (NTE \$50k). Rebate submitted for approval.
 - ◆ Work completed May 2017. Turf Conversion completed April 2017.

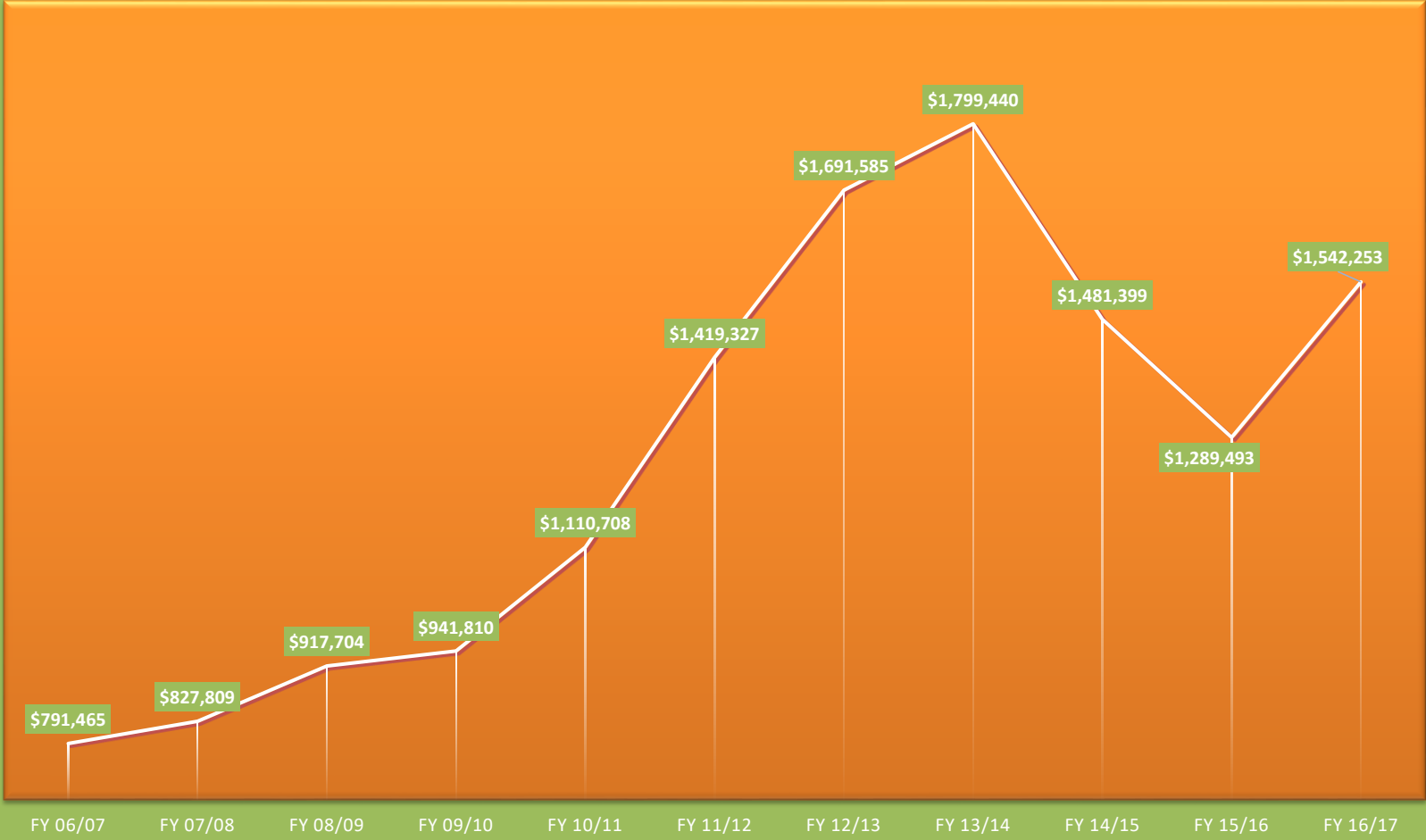
