SUBJECT: California's Severe Drought and Conejo Recreation and Park District's Response in Terms of Water Conservation Recommendations

On May 7, 2015, the Board directed staff to provide monthly reports of the District's water use, water savings projects, and activities to date.

Water Use

Attached is the monthly water use report, including:

- District's Water Usage per Acre (All Funds) from Fiscal Year 2007/2008 to Fiscal Year 2017/2018 (projected),
- Overall Water Costs (All Funds) from Fiscal Year 2007/2008 to Fiscal Year 2017/2018 (projected),
- Rainfall to date from Fiscal Year 2007/2008 to Fiscal Year 2017/2018.

FY 2017/2018 Water Savings Projects and Activities

- Capital and Major Repair Projects
 - Annual Drought Response Irrigation Improvements and Turf Conversions – Districtwide
 - ◆ Projects completed at eleven parks.
 - ◆ Projects work in progress at four parks
 - ◆ Projects to be completed at one parks, in planning stage
 - Annual Master Flow Valve Installations – Districtwide
 - ◆ Projects to be completed at multiple additional parks, in planning stage
 - Master Plan Development and Turf Conversion at Banyan Neighborhood Park
 - ◆ Work completed January 2017

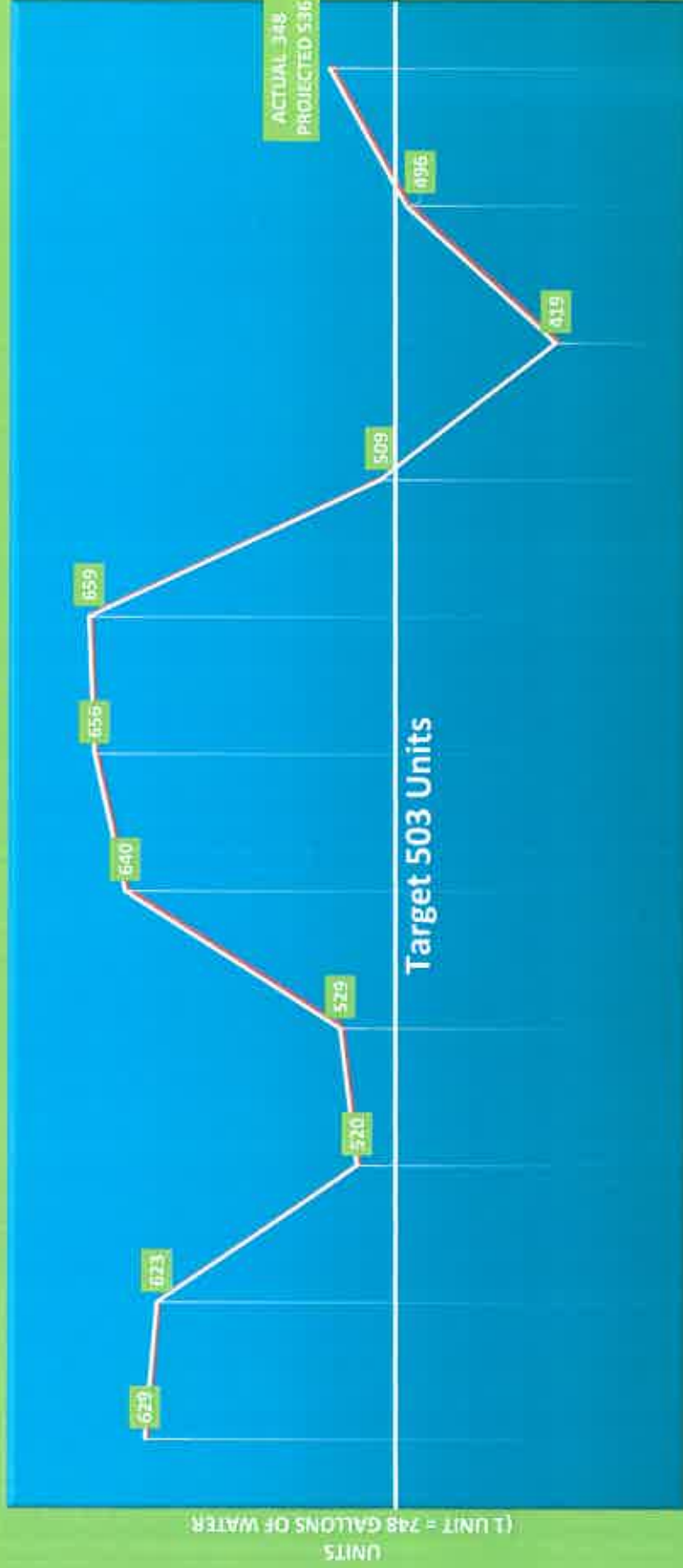

CONEJO RECREATION AND PARK DISTRICT WATER USAGE PER ACRE (ALL FUNDS)

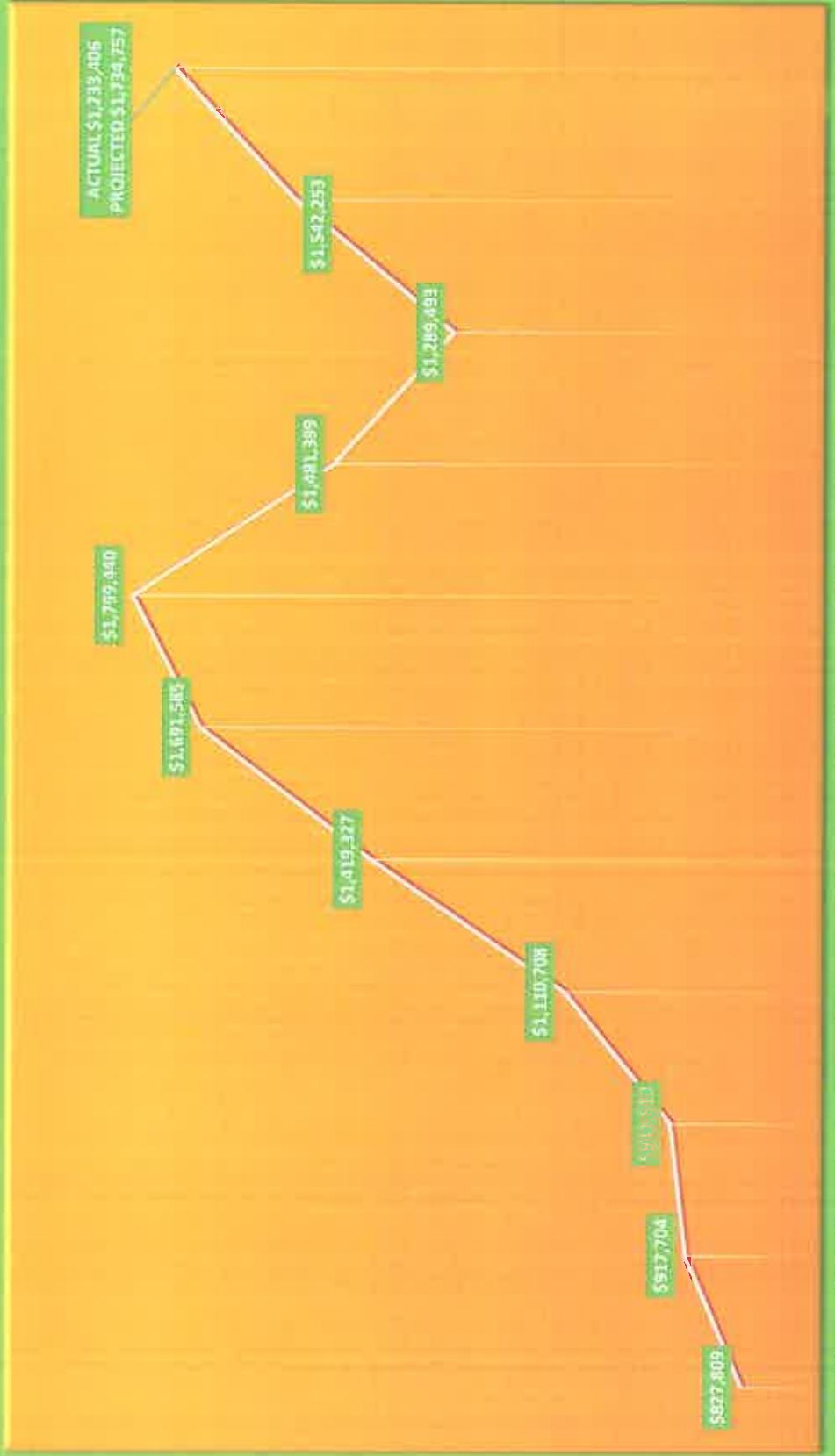

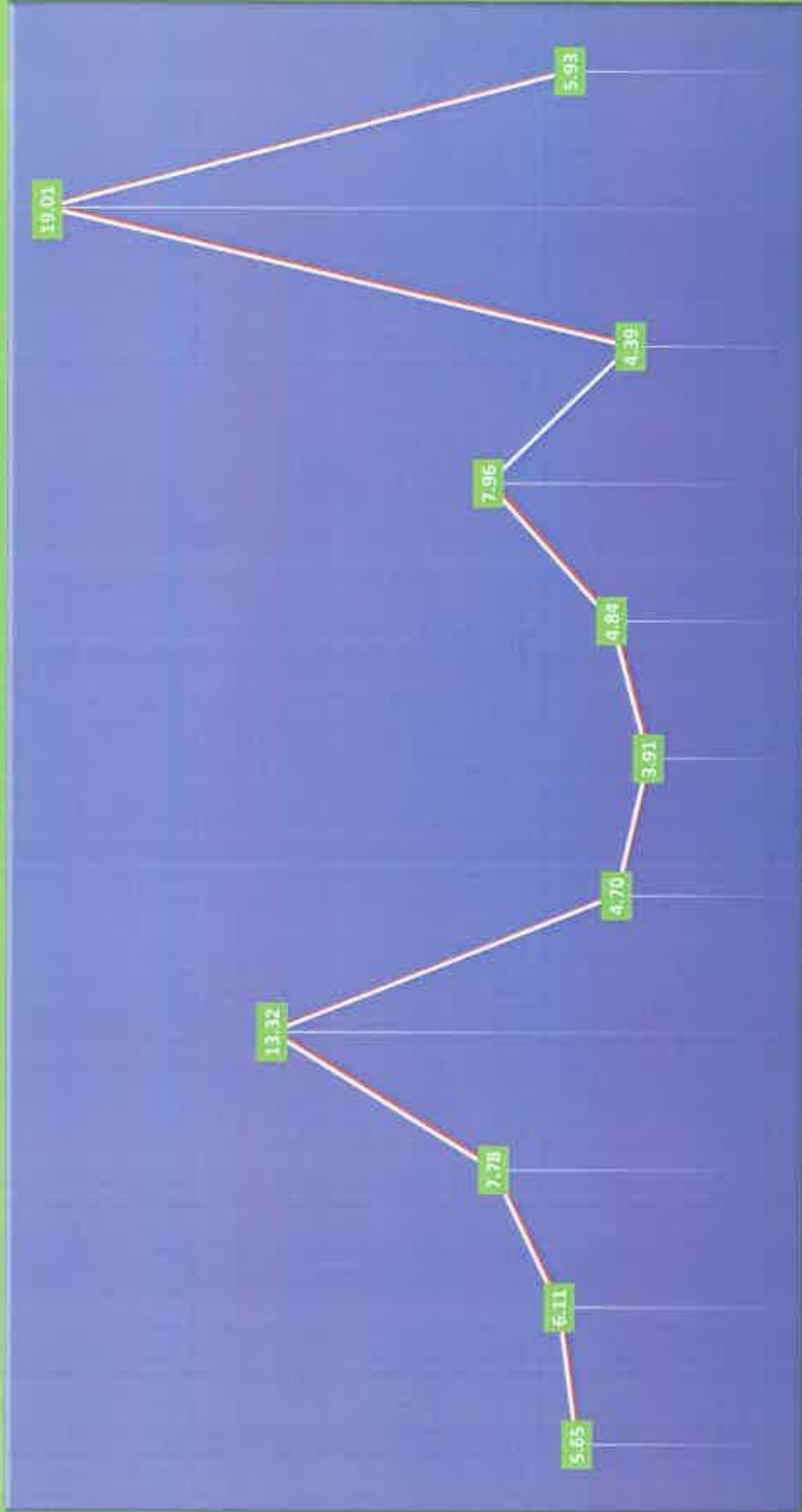
