**FIRST DAY OF CLASS:** Children meet their teacher at the lunch table area immediately after school is dismissed the first day of the session. After the first day, students need to meet at the assigned location.

**LAB FEE: Must be paid at the time of class registration by check, cash or credit card.**

**Lab fee is separate from class fee.**

**PICK UP:** Children need to be picked up immediately after class. Failure to pick up your child on time could result in dismissal from the program without a refund and **A \$1.00 per Minute late fee will be charged.**

**ABSENCES:** Please notify Conejo Center at 805-495-2163 if your child will be absent. Attendance is taken in each class and absences are verified.

**RAINY DAYS:** Rain or bad weather does not cancel programs. Programs will be moved to an indoor area.

**LATE ENROLLMENT:** Class costs will not be pro-rated after classes have begun.

### Cancellations by Conejo Recreation & Park District

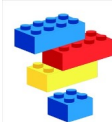
- \* A full refund will be made if a class is cancelled by the district prior to the starting date.

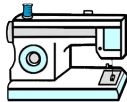
